ARRIVING AND LIVING IN SOUTH AUSTRALIA

On Your Flight

Wear comfortable and layered clothing so you can adjust according to the weather.

Fill in the Incoming Passenger Card which is given to passengers before landing in Australia.

- This is a legal document and you must tick YES if you are carrying any food, plant material including wooden souvenirs, or animal products. This includes fruit given to you during your flight.
- If you have items you don't wish to declare, you can dispose of them in quarantine bins in the airport terminal.
- Ask airline staff if you have any questions.
- Do not carry large sums of money. If you are carrying more than AUS\$10,000 in cash, you must also declare this on your Incoming Passenger Card.

Student Arrival and Enrolment Information

Arrive at least one to two weeks before the start of the compulsory International Student Orientation week to allow enough time for settling-in, adjusting to the climate and overcoming jet-lag.

Effective 1 July 2012, legislation under the Education Services for Overseas Students Act 2000 (ESOS) states that students who fail to enrol within five business days of course commencement will be reported and have your Confirmation of Enrolment (CoE) cancelled.

Cost of Living

Beach and swimming safety

Adelaide summers can be very hot, and many students love to cool off at Adelaide's beautiful white sand swimming beaches. It's important to take care when choosing where and how long to swim.

There are dangers that you need to be aware of, because not everyone returns safely from the beach unless they've careful to consider the following potential dangers:

- Prepare before you go: check out the weather and the time and pick the right spot for your safety
- Can I swim and how well? Do I need some swimming lessons before I swim at the beach?
- How strong and big are the waves and local currents or rips?
- Are there other people swimming?
- Is it safe to swim here? What do the signs say?
- Is there a patrolled, flagged safe zone to swim in with lifesavers? The red and yellow flags show the safe patrolled space to swim.
- Should I just walk or sit in the very shallow water to cool off?
- Ask the locals about dangers and where to swim safely
- Protect yourself from the sun, which causes more damage than sharks or drowning
- Never swim alone.

Accommodation

There are a variety of accommodation options for international students in Australia.

Short Term Hostel Accommodation is a popular option for students in their first few weeks of being in Adelaide. Accommodation can be single or shared and offers convenient, safe and friendly service for a low cost starting from \$100 per week per person.

Student Residence is available throughout Adelaide. They are typically close to public transport and shopping facilities. The main advantage of staying in an International Student Residence is that you will meet and make friends with people of your own age who are also studying. Standard accommodation in an International Student Residence includes:

- a single room with a bed, desk and cupboard
- access to a shared television lounge room

- a shared kitchen and dining area
- laundry facilities
- shared bathroom facilities

Full-Board accommodation typically includes 3 meals per day in addition to the above. Typically, costs for student residences are often between AUS \$235 to \$325 per week for full board.

Homestay accommodation provide students with excellent opportunities to learn about Australia and Australian culture and customs. This accommodation includes:

- single room with bed, desk and wardrobe
- up to 3 meals per day depending on the individual homestay family
- the opportunity to live and learn in an Australian family environment
- use of facilities within the residence

You need to remember that the price you are paying for homestay accommodation may not include:

- telephone calls
- Internet (if available)
- personal items such as toiletries

The price for homestay varies from \$235 AUD to \$325 AUD per week depending on the different facilities and options provided. Please note that these prices are approximate and subject to change without prior notice. The length of stay is arranged between the homestay provider and the student.

Shared Accommodation offers students the opportunity to share an apartment, house or flat with one or more other people. This is often a preferred accommodation option that offers affordable living in and around the city. The price varies dramatically but averages between AUS\$90 to AUS\$215, depending on the different facilities and locations.

Our Student Services team can assist you in locating suitable shared accommodation.

Before Leaving Home

- Make contact with EQUALS
- Apply for a passport
- Arrange a student visa
- Arrange for immunisations and medications from your doctor
- Apply for a credit card and/or arrange sufficient funds
- Confirm overseas access to your funds with your bank
- Make travel arrangements
- Arrange travel insurance
- Advise EQUALS of travel details
- Arrange accommodation if required
- Arrange transport from airport to accommodation, if required
- Pack bags being sure to include the following:
 - Name and contact details of an institution representative
 - Enough Australian currency for taxis, buses, phone calls etc. in the event of an emergency
- Important documents:
 - This handbook
 - Passport
 - Letter of offer
 - Electronic Confirmation of Enrolment (eCoE)
 - Certified copies of qualifications and certificates
 - Travel insurance policy
 - ID cards, driver's licence, birth certificate (or certified copy)

NOTE: Make sure you leave any originals or copies of these documents safely with family in your home country in case of loss. Bring with you only certified copies as required.

- Call home
- Settle into your accommodation
- Contact EQUALS

- Enrol children in school (if applicable)
- Attend EQUALS' compulsory orientation week
- Get Student ID card
- Advise health insurance company of your local Australian address and get OSHC card

Arriving at Adelaide Airport

Adelaide airport is conveniently located 6km away from Adelaide CBD. For more information, visit https://www.adelaideairport.com.au/

Documents required for Customs Clearance

Make sure you have the following documents ready for clearance:

- Your Passport
- Your completed Incoming Passenger Card.

Arrival Procedures

- Follow the 'baggage claim' or 'arrival' sign, where you will approach the Immigration section.
- Queue at the Immigration section (a Customs Officer will advise you to queue in the appropriate section).
- Make sure you have your passport and Incoming Passenger Card ready.
 - An Immigration Officer will ask to see your completed Incoming Passenger Card along with your passport and student visa evidence. The Immigration Officer will check your documents and may ask you a few questions about your plans for your stay in Australia.

Baggage Claim

- Collect your luggage once you have passed through the immigration checks
- Check that nothing is missing or damaged
- Advise the staff at the Baggage counter and seek assistance if there are any problems.

Detector Dogs

When you see a detector dog working close to you, please place your bags on the floor for inspection.

These dogs are not dangerous to humans and are trained to detect odours. A Quarantine Officer may ask about the contents of your bag and check that you are not carrying items that present a quarantine risk to Australia.

Arrivals Hall

You may only be able to leave the restricted area and enter the Arrivals Hall once you have cleared Customs. Here you will find a number of retail and food outlets along with public telephones, an information booth and money exchange facilities.

Airport Pickup Service

EQUALS is pleased to arrange airport pickup upon request. A standard charge of AUD\$65.00 is made for the chauffeured service which includes up to 30 minutes waiting time and transit to the CBD.

Late evening pickups may incur additional charges. Group pickups can be arranged on request. Please contact <u>admissions@equals.edu.au</u> for details.

Airport Meeting Place

When flying into Adelaide on an international flight, you will arrive through the arrivals gate on the ground floor of the airport. This will be after you have collected your luggage and been through customs.

Your driver/welcome party will be waiting for you next to the FOREIGN EXCHANGE BOOTH stall located just near the entrance to the airport and a few metres away from the arrival gate.

Transport from the Airport

Taxis

Taxis (or Ride Share services such as Uber and Ola) are a convenient way to get to and from the airport. There is a designated taxi rank located at the left of the pedestrian plaza as you walk out of the terminal. For more information, visit

Arrive Early

EQUALS provides an Orientation program before the commencement of classes. It is a requirement of the ESOS (Education Services for Overseas Students) Act 2001 that all commencing international students attend this. The Academics and Student Service team who run your orientation activities ensure that you are well equipped and supported to achieve the best possible success in your studies.

Arriving early to attend orientation gives you the chance to:

- See and talk to the most important people you will need to know at EQUALS including:
 - The Student Service team
 - Academic Teaching staff
 - Library staff
 - Professional Experience Advisor
- Receive your Student ID (You will need your Student ID to open bank accounts, borrow books, get your concession card and more.)
- Find your way around the campus including:
 - Library
 - Computer rooms and facilities
 - Recreation and eating areas
 - Classrooms
- Meet other International students who may share your classes, share your concerns or fears. Knowing another face on campus as you become more comfortable with the routines can really help you avoid any feelings of isolation.
- Find your way around the public transport/City/ to and from your accommodation
- Participate in the Buddy Program
- Find out about EQUALS' study support courses which will assist you in your academic course.

Orientation Week

During Orientation week, you are welcomed and issued with your Student ID Card, timetable and lots of information to assist you with your study.

Orientation week is held one week prior to the commencement of each trimester. Please refer to the Academic Calendar on EQUALS' website (http://equals.edu.au/students/) for important dates.

Orientation information is also communicated to commencing students electronically, prior to the start of the event directly to the student. Do check and read all emails from EQUALS on a regular basis.

General English Training

International Applicants

Are you an international applicant?

If you do not possess Australian or New Zealand citizenship, and you do not have permanent residency status for Australia, you are classified as an international applicant.

English Language Requirements

EQUALS International courses are taught in English and therefore you are required to demonstrate English proficiency in listening, speaking, reading and writing by completion of an English language test. The IELTS (International English Language Test System) is the preferred English language proficiency qualification.

The minimum English language entry requirement for our courses is **IELTS 5.5** (overall band score). Band score of each component is not less than **5.0**. Some courses require a score of **6.0** (overall band score) or higher. Please check with the admissions team or visit our website for further information.

IELTS test must be the Academic version. If your English language proficiency does not yet meet the standard, EQUALS will provide guidance in securing the necessary English training for your studies. The final decision on acceptance of any applicant will be based on an interview with EQUALS.

If, once the course has commenced, there are some difficulties arise with the level of English proficiency required, then the student is encouraged to speak initially to the Admissions staff who can guide them.

Level Of Study & Study Commitments

Students undertaking Diploma level qualification can expect to spend approximately 20 contact hours per week. This time is made up of structured lectures, tutorials, structured professional experience placement and other formal study requirements. Students can expect to spend an additional average of 10 – 15 hours personal study and research.

Recognition Of Prior Learning (Rpl)

RPL is an approach that takes into account what individuals have learned from other courses, life experiences, work experiences and training provided at work. It measures this experience against the outcomes of the course students wish to complete. Students will need to produce evidence to support their case. A successful RPL application may lead to a reduction in the length of the course. RPL attracts a fee of 70% of the standard course/tuition fee.

Admission Procedures For International Students

Application for Enrolment in any course/s must be accompanied by the following:

To complete an online application form, you will need to download the International Student Application Form (available from www.equals.edu.au/apply). Alternatively, you can request the form by emailing admissions@equals.edu.au or calling +61 8 8110 1200.

Application Timeline For International Students

Generally, we recommend that offshore students apply no less than 12 weeks prior to course commencement. Students in countries with longer visa procedures, such as Assessment level 3 countries are encouraged to apply at least 6 months before their intended course start date. Student Visa applications can vary from country to country. Please check with your nearest Australian Embassy or High Commission.

Student Visas

You will need to obtain and maintain a student visa until the completion of your course. You can obtain visa information from the nearest Australian Embassy or Australian High Commission or local Department of Home Affairs (DoHA) offices. Student visa applications are assessed based on your country's level of risk (level 1 being low, level 5 being very high). Each assessment level has differing criteria. This criterion includes financial, English and other requirements.

Student Visas

You will need to obtain and maintain a student visa until the completion of your course. Changes Affecting Visa Status

EQUALS International is required by law to notify the DoHA of 'EQUALS International Default' or 'Student Default' as stated within the Student Refund policy/procedure (3-6500) found within the Student Application Form.

For example, including but not limited to whenever a student

- fails to commence the nominated course as expected
- has their enrolment cancelled for failure to meet course requirements, or any other reason
- ceases to occupy the place for which the course enrolment was confirmed, either through completion of, or withdrawal from the course
- changes course and/or provider during their period of stay in Australia.

Overseas Student Health Cover (OSHC)

DOHA requires mandatory, visa length health insurance for all student visa holders. EQUALS' preferred OSHC provider is NIB – www.nib.com.au. A representative from NIB regularly visits EQUALS to assist with renewals and enquiries. Please contact Admissions at admissions@equals.edu.au for the next scheduled visit.

Where requested, EQUALS will assist students to purchase OSHC for the duration of their course. OSHC must be purchased for the entire duration of the Student's course or enrolment with EQUALS International. To not have up to date health insurance is a breach of your student visa.

All student visa holders are required to maintain OSHC cover during their stay in Australia. Details will be provided when enrolling for your selected course and costs can be paid in conjunction with your tuition fees.

Refund Of OSHC Payments

A student may apply directly to the OSHC provider for refund of monies paid if any of the following occur:

- if they do not arrive in Australia
- if their student visa is not extended
- if they have been granted resident status in Australia
- if they are required to return home for reasons beyond their control.

When applying to enrol at EQUALS, students must agree to accept and abide by the expectations, policies and procedures of the Institute. All students are required to agree to our Enrolment Declaration upon commencement.

Course Attendance

International students are required to undertake a fulltime course and expected to attend 100% of the course except in the case of illness or extenuating family/personal circumstances, including bereavement leave. If classes are not attended a medical certificate will usually be required. Students should consult the *Students Handbook (Form 002)* for more detailed information on the Course Attendance Policy.

Part-Time Work

A student visa does not necessarily allow you to work in Australia automatically. In order to legitimately work in Australia, you should contact DoHA after your course commencement. A useful fact sheet from the department's website is available here (https://immi.homeaffairs.gov.au/visas/already-have-a-visa/check-visa-details-and-conditions/see-your-visa-conditions?vcid=171#condition-container). This visa may be an additional cost. Application forms are available from DoHA.

Once you have been granted a right to work you are able to work a maximum of 40 hours per fortnight when courses are in session and full time during semester breaks. You should not rely on work as a means of supporting your study, as it is often difficult to find appropriate regular work. It is also important to remember that your primary reason for being at EQUALS International is to study.

We are particularly committed to assisting our student locate meaningful employment that is within the student's visa guidelines. EQUALS are a registered

employment agency and have extensive networks with local employers in the acute, aged and community health industries. Our staff will link you in to employment opportunities and assist you in your job application process.

Dependants

If holders of a Student Visa have dependents who will be coming with them to Australia, they are required to make arrangements for the education of the dependent/s. Students should contact DoHA for more information about the status of dependents when intending to study in Australia. If you are accompanied by school aged dependents you will be required to pay the full fees for their schooling. Please note that International Students are not eligible for travel concessions on public transport in Australia.

Work Conditions For A Student Visa Holder

International Students are generally entitled to work rights of up to 40 hours per fortnight during course session times and unlimited hours during formal holiday periods. Students are advised to contact DoHA in order to confirm their work entitlements and if necessary, may be required to apply to DoHA.

Change Of Personal Details

If your personal contact or address details change, i.e. mobile, home and/or work phone numbers, address, email address etc., you must advise EQUALS immediately and supply us with an updated list of contact details. Existing students must log into the Student Portal to update their contact details.

Solving Problems | Appeals, Complaints & Grievances

We encourage you to talk with your Mentor/Buddy or our Management when you encounter a problem with any aspect of your experience at EQUALS. We also encourage you to participate in regular evaluations so that we can monitor progress and help solve problems when they arise.

Courses Conducted In English

Language is an important and beautiful part of different cultures. However, to maintain unity and shared understanding between students and staff alike, and to improve the English speaking skills of students, EQUALS expects that English is the only language spoken on campus. In addition, all courses are conducted in English.

Student Course Progress Policy

In line with Department of Home Affairs (DoHA) Course Progress Policy and Procedures for CRICOS Providers of VET Courses, EQUALS monitors, records and assesses the course progress of each Student for the course in which the Student has enrolled. To view the DoHA Course Progress Policy and Procedures and explanatory notes please click visit the **Policies** page on our website.

Students will be enrolled in study periods for the duration of their course. A study period is defined as one term (minimum of 10 weeks) (or mid-term where relevant). Each term consists of a range of Units of Competency which are made available to the Student at the beginning of the study period via the Student's/course timetable. Students are assessed regularly throughout a study period and the progress of each Student is calculated and discussed at the end of each study period during the Student's progress interview.

Attendance will also be considered as part of the course progress. International Students are expected to undertake a fulltime course and to attend a minimum of 80% of the scheduled course contact hours. If classes are not attended, a medical certificate or other supporting evidence may be required. Where a student is assessed as not meeting course progress during an end of term interview, students may be required to make up classes that they have not attended and/or to meet the additional study requirements requested of them as a result of their absence.

Failure to do so may result in a *Competency Not Achieved* unit outcome and/or course suspension or termination. Students will not receive reimbursement for fees if they are absent for a qualification or part thereof. Students may be required to pay the cost associated with extra classes or assessment as a result of their absence. Students are encouraged to consult with Student Services if they have any concerns regarding their course progress.



Deferral For International Students

Requests for the deferral of studies are required in writing using the approved webform in the Student Centre of Moodle. Deferral may be granted by EQUALS International for up to six months (subject to ongoing compliance with visa conditions e.g. for ongoing full time study and the ASQA General Direction: qualification transition and teach out requirements and our Training Package Transition and Teach-out policy) provided advice is given in writing at least 20 working days prior to the commencement of a given term.

Deferral will only be granted between terms for all units or unit components successfully completed in the previous term. EQUALS must notify Department of Home Affairs (DoHA) of your decision to defer your studies in Australia. DoHA will defer the student visa up to 6 months. Over six months your visa may be cancelled, therefore you will need to reapply for another student visa prior to recommencing your studies. Please note that the final decision about your eligibility for a second student visa will be made by DoHA and will be based on your reasons for deferring your studies. Therefore, we strongly advise you contact DoHA to ensure that you will be able to resume your student visa status, prior to making your final decision to defer. Please note that EQUALS is required to notify DoHA of your deferral and you may therefore forfeit your current student visa.

There is no monetary action on deferrals, however, please note that courses may be subject to change and you are required to check with Student Administration at the beginning of the year in which you intend to re-enrol to ensure that re-enrolment is possible. A Student is only allowed to defer commencement or suspend studies of a course on medical grounds (with a medical certificate) or other exceptional compassionate or extenuating circumstances. For more information please read our Enrolment Variation Policy and Procedure in the Policies section of our website.

Withdrawal From Course

Students are required to provide written notification of withdrawal from any course or course component, prior to the commencement of term, in order to obtain a refund for that term. Notification of withdrawal, given after the commencement of term, may not guarantee a refund for that term. Please read the Student Refund Policy/Procedure (3-6500) found within the Student Application Form (F001) and check with Student Administration before withdrawing to ensure that it complies with your student visa requirements.
